- Appropriate funding schemes for entrepreneurship;

- The role of stock markets to ensure growth and expansion of entrepreneurial firms and SMEs:
- The role of universities in fostering entrepreneurship and new firm creation;
- SMEs and debt finance;
- Entrepreneurship, small business and economic development;
- Factors influencing entrepreneurial activity: the role of individual characteristics, cultural and institutional contexts;
- Drivers of small business performance: the role of innovation, R&D and managerial practices;
- Family firms and managerial practices in small businesses.

Contributions concerning the Italian or American context, as well as international comparisons, are particularly encouraged. Theoretical and empirical papers are welcome.

Publication opportunity

After the conference, a selection of high quality papers could be invited for consideration in a special issue of an international academic journal. The papers will follow the normal peer review process. Upon authors consent, presented papers will be included in the conference proceedings published via an academic publisher.
